SOLACTIVE AUTONOMOUS & ELECTRIC VEHICLES INDEX

SELECTION

- The index is designed to track the performance of companies that have or are expected to have significant exposure to Electric Vehicles and Autonomous Driving segments.
- Companies must have relevant exposure to the below:
 - EV - Electric Vehicles: Produce electric/hybrid vehicles.
 - EVC - Electric Vehicle Components: Produce electric/hybrid vehicle components.
 - AVT - Autonomous Vehicle Technology: Build autonomous vehicles and/or develop hardware and software that facilitates the development of autonomous vehicles.
- Solactive ranks the companies in each segment according to the frequency with which each company is referenced in relation to each segment's specific keywords ("Segment Score"). The number of constituents is the following for each segment:
 - EV - The top 15 companies according to their Segment Score.
 - EVC - The top 30 companies according to their Segment Score (Top 15 "Components" + Top 15 "Materials").
 - AVT - The top 30 companies according to their Segment Score.

SELECTION POOL

- Eligible companies must have:
 - Minimum Market Capitalization of \$500 million if they are not current constituents and \$400 million if they are current constituents.
 - Primary listing in a Developed Market, South Korea or Taiwan.
 - Average Daily Turnover of at least \$2 million over the last six months and \$1.4 million for existing constituents.
 - Listing on a regulated stock exchange in the form of shares tradable for foreign investors without restrictions.
 - Free Float percentage of total shares outstanding of at least 10% or a minimum free float market capitalization of \$1 billion.

WEIGHTING AT SELECTION/REBALANCING

- Index components are weighted according to their Free Float Market Capitalization:
 - Each component is subject to maximum weight of 3%.
 - The maximum weight of companies that rank in the bottom quintile of their respective segment is 2%.
 - Companies that are not in the bottom quintile but have the same Segment Score as companies that are in the bottom quintile, would also be capped at 2%.

REBALANCES/REVIEWS

- The index follows a semi-annual schedule of ordinary adjustment, made on the last trading day of January and July each year.
